O R D E R

THIS MOTION, made by the Plaintiffs, for an order requiring the City of Toronto, a non-party to this action, to disclose the identities of individuals who received an injection at any of the clinics set up by Toronto Public Health ("TPH") in response to a potential Hepatitis A outbreak in Toronto and that such disclosure be in the form of an electronic Excel spreadsheet prepared by or at the direction of TPH, was heard this day in Toronto, ON.

ON READING the Motion Record, and on hearing the submissions of counsel for the Plaintiffs and Defendants, and on being advised that the City of Toronto does not oppose this motion,

1. **THIS COURT ORDERS** that the City of Toronto produce a list, in the form of an electronic Excel spreadsheet, comprising the following information (to the extent it is available) relating to each individual who received an injection at any of the clinics set up by Toronto Public Health ("TPH") in response to a potential Hepatitis outbreak in Toronto in the period between August 18 and 31, 2002 (the "List"):
 - (a) first, middle, and last name;
 - (b) home address;
 - (c) phone number;
 - (d) date of birth;
 - (e) gender; and
 - (f) date of injection with the Hepatitis A vaccine or Immune Serum Globulin by TPH.

2. **THIS COURT ORDERS** that the City of Toronto provide the List on a CD-Rom to the Claims Administrator, the Bruneau Group Inc. at the following address:

3. **THIS COURT ORDERS** that the Defendants pay the costs of the City of Toronto in producing the List referred to in paragraph 1 above in the fixed amount of \$2,500.00.


4. **THIS COURT ORDERS** that there shall be no costs in respect of this motion.
