

## Representative Work

Has appeared in every level of trial and appellate court in the Province of Ontario, and on numerous occasions before the Supreme Court of Canada.

Acts on behalf of professionals who have come into conflict with their regulatory agencies, Chris regularly appears before the Divisional Court, the Court of Appeal for Ontario, and before disciplinary bodies, including on behalf of judges and lawyers.

Has supervised the conduct of multi-jurisdictional litigation. He is a frequent lecturer and speaker to professional industry groups on the impact of litigation trends.

SS&C v. Bank of New York Mellon and CIBC Mellon – breach of a licensing agreement in which liability was found against the defendants and our clients are claiming \$880M in damages (2021 ONSC 2657).

Successfully represented the Kerbel appellants in Fram Elgin Mills 90 Inc. v. Romandale Farms Limited before the Court of Appeal for Ontario, in which the court ordered specific performance of a contract for the purchase and sale of land (leave to appeal to the Supreme Court of Canada was denied) (2021 ONCA 201).

Successfully represented the plaintiff in Bain v. UBS Securities Inc. at trial and before the Court of Appeal for Ontario, a case involving one of the most significant damages awards for wrongful dismissal in Ontario (2018 ONCA 190).

Trinity Western v. Law Society – Supreme Court of Canada – Intervenor on behalf of The Advocates' Society (2018 SCC 32).

On July 4, 2017, the Ontario Court of Appeal released its decision in *Angus v. Municipality* of *Port Hope*, which reviews key principles in determining whether obligations are pursuant to contract or trust. Chris Paliare, Richard Stephenson, and Lindsay Scott successfully represented the Municipality of Port Hope as appellant (2017 ONCA 566).

Successfully represented the defendant in Cobb v. Long Estate before the Court of Appeal for Ontario, an appeal concerning the application of significant amendments to the Insurance Act in motor vehicle accident cases (2017 ONCA 717).

Represented Edith Neuberger in Neuberger v. York, 2016 ONCA 191, a leading case about estoppel and the conduct of Estate Trustees. Our client was successful at the Ontario Court of Appeal, and leave was denied at the Supreme Court of Canada (2016 CanLII 60508 (SCC)).

Successfully represented the plaintiff in Club Resorts Ltd. v. Van Breda before the Court of Appeal for Ontario and the Supreme Court of Canada, which redefined the test for the assumption of jurisdiction over foreign defendants in Ontario (2012 SCC 17).

Dunsmore – A historic decision of the Supreme Court of Canada that allowed farm workers the right to join trade unions applying s. 2(d) of the Charter of Rights and Freedoms to override the prohibition in the Ontario Labour Relations Act (2001 SCR 1016).

Regina v. Murray Howard – Supreme Court of Canada successfully gave the client a new trial on a charge of murder (1989 1 SCR 1337).
